i. Treasurer and Secretary roles 2020 onwards

iii. Capitation, to be reviewed as per rule 8c

President attendance at LCI conference— 250 Euro
President attendance at 41 International Conference — 250 Euro

The Capitation fee shall be based on member count as per 31 December each year

iv. Board member funding

How will TCI expect elected Board members to be funded?, from TCI central funds, by the candidate themselves or by their Country National Boards? If the elected TCI board members are expected to be funded by themselves this could lead to an elite group who would only stand because they had personal funds to do so.

v. Presidents travel funding

As the number of TCI countries grows there will be more travel for the President. If this is funded by TCI, then TCI Capitation will need to be increased. How will this be achieved? Will this this mean moving to capitation per member? (We realise that the present capitation was fixed for an initial period of 3 years from 2016 and is to be updated at the TCI AGM 2019).

- 7.d. The TCI HYM where possible is to be held in conjunction with 41 International HYM, or otherwise preferably in conjunction with the TCI President's National HYM.
